Presidents Letter By RAA President Ted Gablin

There are 5 major issues affecting our airport that we have put at the center of the RAA's focus. After you read about them I am sure you will agree that they are huge problems. There are other issues besides these that also affect REI. Unfortunately there just aren't enough of us to tackle all of the issues at the same time. The abuse our airport has endured has occurred over a period of years. It's not going to get fixed overnight. Here's where we are on our "Big 5":

#1 Housing Encroachment/Development near the Airport.

Since we last published the newsletter this issue has been the focus of almost all of our attention. A proposed zoning change and a 55 home development recently went to the city council for approval. The proposed development is adjacent to another tract that was questionably approved in 2008. The development is also under the crosswind approach for Runway 26 and the City established helicopter training pattern. ATA students overfly this property all day at about 400'agl. They are the largest business at REI. We all know how this will end if these homes are built.

The developer claims he meets CA environmental requirements and has filed a mitigated negative declaration. The developer's traffic engineer measured the noise **from one aircraft** and stated the houses were not in the airport flight plan.

The California Environmental Quality Act (CEQA) requires a full Environmental Impact Report (EIR) anytime a zoning change is contemplated in an airport influence area. That is the law and it hasn't happened. The focus of an EIR of this nature would be a detailed noise study of the impact of airport noise, and safety associated with aircraft overflight of the planned development.

Additionally, the City of Redlands does not appear to be abiding procedurally by the CA PUC statutes regarding airport land use reviews as stipulated in their filed Airport Land Use Compatibility Plan (ALUCP). The ALUCP was adopted by City of Redlands resolution on February 18, 1997.

With the public identification of these issues and many phone calls, letters and meetings with government officials, the Redlands City council vote on approving this development was initially delayed until October 6, to give the city time to hire an aviation consultant and attorney to advise them on the approval of this development. On October 6th council deferred review of the development again and approved hiring aviation consultant Coffman and Associates. The proposed development is currently scheduled to be reviewed by City Council on November 17, 2015.

We are not sure where this one will end up. We hope the City does the right thing here for the airport and City of Redlands taxpayers that may be faced with the liabilities associated with approving the development. Work in progress.

The "Big 5" Issues at REI

#2 Citrus Reservoir Stockpile Removal

California Department of water Resources (CDWR) is almost complete with their construction of a reservoir less than ½ miles from the approach end of runway 26 at REI. The stockpile, although diminished in height, is still an obstacle to pilots using REI.

The County of San Bernardino has not renewed the property owner's temporary use permit for the stockpile as a result of our efforts and the City of Redlands. We recently convinced the County of San Bernardino to start code enforcement action on the property owner who acquired the dirt as his permit has expired. Work in progress.

#3 Future Citrus Reservoir Wildlife Issues and REI

The 2009 CDWR approved Environmental Impact Report for this project states that appropriate design features and a wildlife management plan meeting FAA requirements will need to be developed by CDWR and City of Redlands as a condition of the approval to construct this project. The RAA will work to insure the stated mitigation measure happens. Work in progress.

#4 Establishment of a Volunteer First Responders Group

About 2 years ago, the City of Redlands removed a donated dedicated emergency pickup truck and most of the fire equipment it contained from the airport. The keys for the truck were always in the vehicle in a carport at the airport. The City cited liability concerns about strangers driving their vehicle. The nearest fire station is at least 7-9 minutes away from REI. Response time is longer. The last time there was an accident at the field it took almost 20 minutes before fire crews arrived. The RAA is trying to get fire equipment back at REI. The City just received a \$2500 donation from Hangar 24 breweries for fire equipment for the airport. The RAA has floated a proposal to the City to have some volunteers trained at the airport to act as first responders. **We never received a response from the City of Redlands to our proposal.** Work in progress.

#5 Managing Issues with Hangar 24's Airfest events

We were recently notified that Airfest 2016 is scheduled for May 14th 2016. We sent an email to members encouraging participation in the event. On Tuesday 9-15-15 we learned Hangar 24 had a planning meeting. Even though they are looking for airport participation we were not made aware of the meeting. Not a good start. Maybe it was just an oversight. Since that date we have opened up a dialog with Hangar 24 about the event. An AAB subcommittee will be formed again to provide some oversight for Airfest 2016. RAA wants to be sure that airport users get the same consideration they received in the 2015 event. We also would like to see airport participation in the Airfest event. EAA 845's involvement in the "Kid Zone" was a big reason for the success of Airfest 2015. We hope they do this again. The involvement of the airport community will just make this more of an aviation event. With that said, Hangar 24 will be having a planning meeting for Airfest 2016 on October 14th between 6-7pm. The meeting will be held at their facility at 310 Nevada St. They are looking for airport volunteers. The Hangar 24 contact is Becca Clemens. Here e-mail is: rclemens@hangar24charities.org

So where is this all going? We have seen some progress as a result of our collective efforts. We are starting to develop a working relationship with the City of Redlands. City officials supported our efforts to get a better Airfest event this year. There are a few officials at the City that committed to look into the issues around residential development in the airport influence area. Some airport users will be proving airport related input to the Redlands General Plan update project. All of this accomplished as a result of the participation of many in our airport community. Let's keep up the effort. Be patient, the wheels of government turn real slow. We won't change things overnight. It's going to take time, effort and your help.

Stuff a Plane With Toys For Tots

If you haven't heard, the RAA, in cooperation with the USMC and co-sponsored by EAA Chapter 845, the Redlands Flying Club, and the City of Redlands are planning a charitable event entitled "Stuff a Plane with Toys for Tots". This is a "Toys for Tots" drive kickoff that will be in conjunction with an airport open house, aircraft static exhibits, car show, motorcycle show and fly- in.

Collected toys will be delivered to the USMC by volunteers via a personal aircraft caravan from REI to TNP tentatively on 12-12-15. Net proceeds (after event expenses) from donations made at the event will also go to Toys for Tots.

This event is intended to support a great cause and get the community to the airport. There will not be any impact to airport operations other than having the west gate closed to vehicle traffic during the event and the attendance of many guests on the west ramp. Coyote Aviation tenants will have runway access during the event and volunteers will help to guide visitors around the airport. EAA 845 is also planning a Young Eagles event that day to further support the event. After a few bumps in the road this event was approved by Redlands City Council on 9-15-15.

So what do you need to do? Well at a minimum, show-up and open up your hangar. Voluntary donations of a new unwrapped toy or (tax-deductible) cash or check are welcome. Event proceeds will be donated to Toys for Tots by the Redlands Airport Association, a Chapter of the California Pilots Association.

You can also volunteer to help, try to sell some of your no longer loved aviation stuff, show your plane, car or motorcycle.

We want to get set up quickly and orderly the morning of the event and if you are interested in the swap meet static exhibit or car and motorcycle show please review the site plan for locations of these activities and review the following instructions for participating:

Aviation Swap Meet

Haul your "merchandise" up to the aviation swap meet area on the morning of the event. You can start setting up at 8 am. We will need you to be completely set-up by 9:45. We don't want a lot of traffic on the west ramp when the gates open to the community at 10 am. It's all about safety.

The "Stuff a Plane with Toys for Tots Event" has been advertised to the flying community and we are sure there may be sales opportunities before 10 am. You may want to bring a table, rug or fancy drop cloth to display your merchandise. You will be on the ramp without shade, so you are welcome to bring your EZ-up if it's not breezy. Or, just make sure you have it weighted down.

If you have big items in your hangar (like a project) just snap a photo or make a sign to advertise your stuff. If you get some interest, just take that person to your hangar. Proceeds from any sales you make are yours to enjoy. The event is over at 3pm and we would like you to pick up any unsold merchandise at that time so we can clean up the ramp.

<u>Aircraft Static Display</u>

We would like to get display aircraft parked in an organized fashion before the event opens to the community at 10 am. It's all about safety. We want to limit aircraft taxing on the ramp during the event to Coyote tenants and transient aircraft.

If you would like to display your plane please plan on parking your aircraft where directed on the ramp between 8:15 and 9:45. Please plan on having your plane displayed until 3 pm.

If you need the plane prior, no worries, just let Steve know and you will display in the area designated for transient aircraft. Volunteers will be on hand on the morning of the event to guide you to parking. Unfortunately, bollards and ropes will not be provided for aircraft on display. We will have some volunteers keeping an eye on displayed aircraft, but be prepared to help watch your plane. Bring a lawn chair, some shade and be prepared to talk to people about your ride.

Car & Motorcycle Display

A few of our members and others on the airport have classic/custom cars and bikes. We would like to get display vehicles parked in an organized fashion before the event opens to the community at 10 am. It's all about safety. We want to limit vehicle movement on the ramp during the event.

If you would like to display a vehicle please plan on parking in the designated areas on the ramp between 8:15 and 9:45. Please plan on having it displayed until 3 pm.



Fuel; The Go Juice of Aviation

Seems like a simple item. Just pump it out and fly your plane.

The care of your fueling operation can affect the success of your flight. Grounding your aircraft is very important. A discharge from the nozzle to the tank can result in fire and/or explosion.

Our fuels are actually very complex. Lead prevents premature detention of the ignition in our engines. The chemistry of their formulation keeps aviation fuel almost indefinitely fresh. The fuel is formulated to not freeze in freezing environments. We have a lot to be thankful for, even though it costs so much.



In pre flights with students, instructors like their students to check the quantity and quality of the fuel.

The quantity is to insure the student has planned for adequate fuel for the mission to be flown, plus a reserve. Physical measurement is always best for this as the gauge (by FAA requirements) only needs to be accurate when the tank is empty.

The quality is the examination of the fuel for contaminants like dirt or debris in the tank that could block a filtration system. Water is the other primary contaminant, and can be present due to fueling during rain, leaving the tank low after a flight and having the atmosphere condense yielding water.

Water is no issue if trapped by the low level filter known as the gascolator, and drained before flight. The issue arises when the bowl becomes full of water (due to not being drained), and water reaches the carburetor or throttle body, and is introduced into the cylinder for compression and combustion. Water, not being volatile, makes a poor fuel and the engine either sputters or quits. This results in altitude loss and an unplanned landing.

As a precaution, make sure your gaskets on the fuel caps are tight and water can't drain into the fuel tanks in low spots or wells (more common on older aircraft). Try to leave tanks full to prevent atmospheric pockets in the tank that could condense water from the air with temperature and pressure changes.

Fuel is the food your engine eats. Make sure your aerospace machine has the best quality food to propel you to new heights and destinations --- safely.
