## **Access to East Ramp**

There will not be any access to the east ramp behind the 300' crowd line during the airshow waiver period. All airport users will have access to their hangars before and after the TFR.

#### Aircraft on the West Ramp Requiring Temporary Relocation

The City of Redlands has sent a letter to the owners of these aircraft notifying them that they will need to relocate them temporarily. This letter went out 4-7-15 and is on page 3 of this newsletter. We are hearing that Hangar 24 has hired David Gee to move these aircraft.

### **Instructions for Tenants About Vacating Hangars for The Event**

A temporary Flight Restriction (TFR) notice will be issued between 2:30 p.m. to 7:00 p.m. Hangar tenants and visitors will need to vacate the east ramp area prior to the TFR and non-airshow flights will still be restricted. Redlands Police Department will provide a reminder to tenants to vacate the hangar area prior to the TFR. All tenants will have access to their hangars following the TFR.

#### **Hangar Tenant Access to Airfest**

Hangar 24 Charities will provide hangar tenants and their guests' admission into the spectator area for the event. Tenants will receive free parking to the event, and may enter along Wabash. Admittance to the parking area will be provided by showing your assigned airport gate access card and by identifying yourself as a tenant. It appears tenants will be parking on the airport. *When parking, please do not block access to other people's hangars and taxiways.* Please see the site map on page 4 for entrance information. Airfest can be accessed by tenants and hangar owners from the airport property on foot. With ticket in hand, airport users can enter Airfest through a gate in the vicinity of Eric Paul's last hangar (follow steps down to gate).

SUBJECT: AIR FEST EVENT MAY 16, 2015

To Whom It May Concern:

Hangar 24 Charities Air Fest event will be held on May 16, 2015 at the Redlands Municipal Airport. During this time, a Temporary Flight Restriction (TFR) Notice will be issued between 2:30 p.m. to 7:00 p.m. and non-airshow flights will still be restricted. Please note that additional activities for the Airfest event will continue along the west ramp area throughout the evening, which includes a static airplane display and live music.

The spectator area for the event will be located along the west ramp of the Airport. To accommodate the Federal Aviation Administration crowd line for the airshow, all east ramp hangars will be closed during the TFR. Redlands Police Department will provide a reminder to tenants to vacate the hangar area prior to the TFR. However, all tenants will have access to their hangars following the TFR.

Hangar 24 Charities will provide tenants and their guests' admission into the spectator area for the event. Further, tenants will receive parking to the event, and may enter along Wabash. Admittance to the parking area will be provided by showing your assigned airport gate access card and by identifying yourself as a tenant. Please see the enclosed site map for entrance information.

For those tenants that utilize the tie-down area of the west tarmac, the City requests that all aircraft be moved by May 13, 2015 to facilitate the event setup. Please contact Redlands Aviation at (909) 262-0569 for a space in the east end of the airport.


As a reminder, consumption of alcohol outside of the designated beer-garden or open flame BBQ is strictly prohibited on the premises pursuant to the Redlands Municipal Code (Section 12.56.090 and Section 12.56.390, respectively) and the hangar lease agreement. The spectator area is the only designated place for alcohol consumption during the event. Further, please note that spectator activities will continue along the west ramp after the TFR has expired. Tenants that choose to fly outside of the TFR are reminded to use caution and due regard to the spectators.

## **Caution in the Wind**

Recently we have had some winds that were high in velocity and from different directions. Wind is a fickle thing and the understanding of cross winds is particularly important to the aviator. I often hear pilots say they would rather wait till the winds are calm. The problem with this is they never get to understand the nature or the mastery of cross wind take offs and landings. Let me say, you should avoid crosswinds that are at, or beyond, the demonstrated crosswind component your aircraft was certified for.

Understanding the wind is a foreign thing. The atmosphere is comprised of gases we cannot see or smell. The fact they offer forces that keep our airplane aloft is often taken for granted or forgotten. It is important to remember, it is a fluid and that we live in an ocean of air. As humans, we are bottom feeders; as aviators, we get to rise and explore other areas of the sea we live in. Proper understanding of currents is critical to divers, but for some reason we tend to dismiss the same phenomenon that exists in the air around us.

Alignment with the runway is two dimensional until we apply power and the aircraft takes flight. It quickly becomes three dimensional as the airplane suddenly moves sideways; we are often surprised and start a corrective action. Winds are reported FROM a magnetic heading, this is to help the pilot decide which runway to use as the runway faces TO a magnetic heading. Very simply, if the winds are from a heading that is greater than your runway heading; they are from the right. Conversely, winds from a heading less than the runway heading are from the left. This is a clue. If substantial enough, they could move your airplane sideways. Unwind the landings you were taught by running them backwards for the takeoff. As your velocity increases, introduce aileron into the wind and correct for drift with the opposite rudder. This will keep you aligned with the runway. After rotation, and as your airspeed builds, turn into the wind to a heading that will keep your ground track over the centerline of the runway with the ball centered. This is the classic crab used on the approach to the cross wind landing. Maintain this heading as you climb at best rate, and you are in command of the drift!!

As with most aspects of flying, complete understanding is the key to successful maneuvering. You could, after a long cross country, arrive at an airport experiencing a cross wind. This would be exactly the wrong time to learn about them. Use your flight review or get your instructor to offer you education and confidence to fly in an environment you might not fully understand. Take advantage of his or her knowledge to improve your skill set. It will only make you a better pilot.


